I asked if her dog shot records was up to date. she said she got her vaccines from Pit Bull Paridise. I then explained that situation to Ms. Dore, and what she needed to do to get things in order. "Runt" can be redeemed as long as they bring photographic proof that Dangerous Dog signs are posted at 2 main entrances the upstairs and downstairs and on the 3 gate entry points. They are to bring the muzzle leash and county license with them in order to redeem "Runt" and provide that proof to the shelter staff.

10/19/16 ACO Cotten, and ACO Blixt did a visual inspetion of the property. All of the appropriate signs were in place except one, and Ms. Dore is making one to replace the one that was missing. She is to email ACO Cotten a picture when the sign is placed. This confirms the proper placement of signage. RCotten

10/10/16 Attempted to deliver Notice of Meeting for Dangerous Dog Investigation, owner would not answer the door. A child's voice could be heard, and the owner's other German shepherd was barking inside the home. This officer knocked on all three doors of the downstairs portion of the house, both sides, and the front, which is to the garage. I also went up the outside stairs, but the small gate at the top was locked, and the owner's white pit bull was on the deck. The Notice of Meeting was left on the downstairs door facing the driveway to the east of the house. Another copy will be sent certified mail. RCotten

10/10/16 Returned to 14150 Canal Dr. after working another call. The paperwork was moved to a lower point of the door where this officer attached it. Ms. Dore exited the west door of the house came around to the east, and she was given the Notice of Meeting. She also signed for them. RCotten

10/13/16 Ms. Dore, and a Mr. Edward Morgan, appeared on Thursday morning at the COC for the meeting with LT Monfreda, SGT Nowlin, and SGT Jankowski, with ACO Blixt sitting in. I, ACO Cotten, presented the case to the panel, and the owners. After questions by the panel, and the owners were answered, ACO Cotten, and ACO Blixt went into another conference room, while the panel discussed the case to make their determination. Both owners were cited for the incident on October 3, 2016. Both citations were for Roaming at Large, and Animal Nuisance (bite to human) with 2 citation surcharges for a total of \$1010.00 each. Their mandatory court appearance is November 3, 2016 at 8:30AM. The owners departed the County Office Complex. ACOs Cotten, and Blixt went back into the conference room with the panel, and it was discovered their decision was to find Runt a Dangerous Dog with restraining restrictions. There was no recommendation for euthanasia, and there was no suggestion of such. An attempt to contact either, or both, owners will be made later today. RCotten

On 10-03-16 at about 2000hrs. I got a call to go to 13910 Canal Dr. in reference to a dog bite. When I got to the address I spoke with the victim of the dog bite, Ms. Malinda Swigart. Ms. Swigart said she was jogging by the address of 14150 Canal Dr. when she noticed the bite dig on its own property. She said the dog ran from the property in an aggressive state. Ms. Swigart said she faced the dog at first, but when she started to turn to get distance between her and the dog. The dog bit her on the buttocks. The S.O. that was on scene took a picture of Ms. Swigart wound. The wound seemed to have been made from the dog. I then went to 14150 Canal Dr. to talk to the owner of the bite dog. Mr. Edward Morgan. I spoke with Mr. Morgan about the situation, and what would take place in the situation. The Bite dog was an eighteen month old, black and tan, female, German shepherd, named Runt. Caller states the German Shep that was deemed a dangerous dog, has been out the past week RAL. She has video and pictures of the dog being out. I asked her if the dog was still out she was not sure, the last time she seen the dog it was in it's yard with the other two dogs that live there. I patrolled past area and all dogs were back inside the home. L.Samford

07/19/17 Made contact with complainant, got positive identification of the dog named 'Runt', the previously designated dangerous dog. The pictures Mrs. Tipsword has are of Runt in the owner's driveway with no leash, no muzzle, and no competent person in control of the dog. There is also no collar, or tags. I contacted SGT Jankowski, he instructed me to contact Escambia County Assistant Attorney Bobbie Ellis-Wiggins. I called her office, spoke to Shawn Hunter, and she left Mrs. Ellis-Wiggins a message to call me. RCotten

07/20/17 LT Monfreda, and I, ACO Cotten, met with Assistant County Attorney Bobbie Ellis-Wiggins. It was decided that more information was needed in order to determine the appropriate action. RCotten

07/25/17 I made contact with the caller by telephone. She stated that the day her dog was attacked, May 12, 2017, the German shepherd identified as Runt did charge from the open gate of the owner's chain-link fenced back yard into the road, and attacked her dog. She expressed the dog approached quickly, and with the obvious intent of attack. She also stated the male owner was chasing Runt, and was only able to catch her after she had attacked the caller's dog. Later in the day, SGT Jankowski and I made contact with Sandy Dore at 14150 Canal Drive. Upon our arrival, Runt was in the fenced back yard, unleashed, unmuzzled, and no person in direct control of the previously designated dangerous dog. Mr. Edward Morgan arrived within minutes. SGT Jankowski told them to place the dog on the county truck. They could not produce current rabies vaccinations, or county license for Runt. Both owners were cited for the incident on May 12, 2017 for Roaming at Large (RAL) Mandatory Court (MC), Animal Nuisance (aggressive attack to another animal) MC, and Violation of Dangerous Dog Requirements (VDDR) MC, with 3 citation surcharges, and clerk fees & costs. The total of both of these citations ranged from \$880.00 up to \$1530.00 to be determined by the judge. CONT>

Ms. Dore, and Mr. Morgan were then cited for another day, June 17, 2017, for RAL/MC, and VDDR/MC with 2 citation surcharges, and clerk fees & costs for \$825.00 up to \$1025.00. Then, for the violations witnessed this day by both SGT Jankowski, and I, they were cited for Animal Unvaccinated Against Rabies/MC, Animal Unlicensed/MC, and VDDR/MC, 2 citation surcharges, and clerk fees & costs for \$1120.00 up to \$1520.00.
